Precinct 1 – To be comprised of the entire township, the areas previously know as Precincts Kaska and Cumbola.

Township of Branch

Precinct 1 - To be comprised of the entire township, the areas previously know as Precincts East and West.

Township of Cass

Precinct 1 - To be comprised of the area previously known as Precinct North and the northern parts of Precincts South and South West.

Township of Cass

Precinct 2 - To be comprised of the southern parts of the areas previously known as Precincts South and South West.

Borough of Coaldale

Precinct West - To be comprised of the area previously known as Precincts West and the western part of the Precinct Middle.

Borough of Coaldale

Precinct East - To be comprised of the area previously known as Precinct East and the eastern part of Precinct Middle.

Precinct 1 - To be comprised of the area previously known as Precincts North and South.

Precinct 4 - To be comprised of most of the area previously known as Precinct 4 except the area between South 3rd Street and Llewellyn Hwy and with the addition the area from Precinct 1 west of the centerline of Woodward Street.

Precinct 1 - To be comprised of the western part of the area previously known as Precinct Mellotts.

Precinct 2 - To be comprised of parts of the area previously known as Precincts Adamsdale and Mellotts.

Precinct 3 - To be comprised of parts of the area previously known as Precincts Adamsdale and Mellotts.

Precinct 1 - To be comprised of the area previously known as Precincts Marlin and part of Precinct Currans.

Precinct North - To be comprised of most of the area previously known as Precinct North with the addition of the area from Precinct West, north of the Conrail Railroad.

Precinct West - To be comprised of most of the area previously known as Precinct West with the exception of the area north of the Conrail Railroad.

Precinct 1 - To be comprised of the area previously know as Precincts 1, 2 and 4.

Precinct 2 - To be comprised of the area previously know as Precincts 3, 5 and 7.
