IMPORTANT DATES TO REMEMBER

MAY 13 – All absentee ballots, except those received from military and overseas electors, as defined by sections 1301 (a) to (h) of the Pennsylvania Election Code, and those received from emergency absentee electors who become ill or are called away from home after 5 o'clock P.M. on this day, must be received by the County Board of Elections not later than 5 o'clock P.M. on this day to be counted.

May 18 – First day to register and change party or non-partisan enrollment after Primary.

May 20 – On this day, the County Return Board meets at 9 o'clock A.M. at the Schuylkill County Election Bureau, 420 N. Centre St., Pottsville PA 17901, to compute and canvass the returns of the Municipal Primary Election.

May 24 – All absentee ballots from military and overseas electors, as described by sections 1301 (a) to (h) of the Pennsylvania Election Code, must be received by the County Board of Elections not later than 5 o'clock P.M. on this day and must be postmarked not later than May 16 to be counted.
