IMPORTANT DATES TO REMEMBER

November 2 – All absentee ballots, except those received from military and overseas electors, as defined by sections 1301 (a) to (h) of the Pennsylvania Election Code, and those received from emergency absentee electors who become ill or are called away from home after 5 o'clock P.M. on this day, must be received by the County Board of Elections not later than 5 o'clock P.M. on this day to be counted.

November 7 – First day to register and change party or non-partisan enrollment after the Election.

November 9 – On this day, the County Return Board meets at 9 o'clock A.M. at the Schuylkill County Election Bureau, 420 N. Centre St., Pottsville, PA 17901, to compute and canvass the returns of the General Election.

November 13 – All absentee ballots from military and overseas electors, as described by sections 1301 (a) to (h) of the Pennsylvania Election Code, must be received by the County Board of Elections not later than 5 o'clock P.M. on this day and must be postmarked not later than November 5, to be counted.
