ESTATE FILING INFORMATION & REQUISITES

All Petitions for Letters must include:

1. Original Petition (plainly printed in black ink or typed)
2. Original death certificate
3. Original Will (if applicable)
4. Original and one copy of the Estate Information Sheet
(Do not insert the personal representative(s) social security number on any document)
5. Valid proof of identity

With regard to the entire fee schedule, be advised that this office will no longer extend credit as to any filing fees. All fees must be cash/check at the time of filing.

No “unknown” values will be accepted for gross estates (except litigation). A reasonable estimated value will be the basis for the initial filing fees charged. Any difference in the amounts must be paid when the inventory and/or inheritance tax return is filed.

The decedent’s residence must be noted: i.e. borough of, township of or city of.

All fees must be paid at the time of filing – Cash.

All petitions for Letters must be signed by the personal representative in the presence of office staff. (signed exactly as named in will).

Attorney of Record must include his ID number, typed name, address and phone number on all filings.

Bonds are required for all out-of-state Administrators and Executors (unless excused from bond in the will).

Non-subscribing witnesses must appear in our office.

No Certificates/Letters may be issued until all procedures have been completed and requisite forms duly executed.

Estate number must appear on all subsequent filings.

All other requests for mailings (i.e. short certificates, receipts, photocopies, etc.) must include a self-addressed stamped envelope of adequate size and postage to cover request and payment for requested document.

Petitions for Adoption must include the following:

1. Birth places of parents (both natural and adopting)
2. Date of birth of parents (both natural and adopting)
3. Mother's maiden name (both natural and adopting)
4. Social Security Numbers of parents (both natural and adopting)
5. Original birth certificate of the child being adopted

Prior to the Adoption Hearing, State Form No. _____, Certification must be completed and filed at the Clerk of the Orphans' Court Office. When the adoption is completed, the Clerk will certify the document and send to Vital Records. You may request a new birth certificate from Vital Records 4 to 6 weeks upon completion of Adoption.

Orphans' Court Filing Information & Requisites

All Petitions must be verified.

Orphans' Court or Estate File Number must appear on all petitions.

All Petitions must be filed with this office before transferring to Court.

Only one (1) name per case number/filing.

All Orphans' Court filings must include the Attorney's name, address, phone number and ID number (not firm name).

After the expiration of a rule returnable date and in order for a record to be transmitted to the Court for disposition, a Praeceptum to Transmit (Schuylkill County Orphans' Court Rule 2.4D) must be filed. (The Praeceptum to Transmit does not get filed with the original petition.)

All other requests for mailings (i.e. certified orders, guardian's short certificates, receipts, photocopies, etc.) must include a self addressed stamped envelope of adequate size and postage to cover request and payment for requested document.
