## REQUEST FOR TAX LIEN CERTIFICATE

All blanks must be completed. Fee is \$15.00 per parcel, payable to the Tax Claim Bureau. If certification is to be returned by mail, a stamped, self-addressed envelope MUST accompany request. Please allow 72 hours for processing.

**PLEASE NOTE FOR SCHOOL REAL ESTATE TAXES:** the Tax Claim Bureau **cannot certify** delinquent real estate taxes for the years **2000 through 2007, inclusive**, for properties located in the **PANTHER VALLEY SCHOOL DISTRICT**; and for the years **2004 and 2005** for properties located in the **GREATER HAZLETON AREA SCHOOL DISTRICT**; 2004 through 2007 for the **SHENANDOAH VALLEY SCHOOL DISTRICT** and the **TAMAQUA AREA SCHOOL DISTRICT**; 2013 going forward for the **ST. CLAIR AREA SCHOOL DISTRICT**.

**PLEASE NOTE FOR MUNICIPAL REAL ESTATE TAXES:** the Tax Claim Bureau **cannot certify** delinquent real estate taxes for the years **2004 through 2006** for the **BOROUGH OF TAMAQUA** OR FOR TAX YEAR **2010 AND 2011** FOR THE **BOROUGH OF FRACKVILLE**

**FOR PARCELS FORMERLY IDENTIFIED AS COAL PARCELS THE SAID BUREAU CAN CERTIFY ONLY FOR TAXES BEGINNING IN 1997 UNLESS THE FORMER COAL PARCEL TAX MAP NUMBER IS PROVIDED.**
